### **NEW BUSINESS**

# a. <u>Consider Waiver of Preliminary/Final Plan For 26 East Charlotte Street</u> (Countywide Communications Tower)

Lancaster County-Wide Communications is proposing improvements on an existing 2.65 acre parcel located at 26 East Charlotte Street in Millersville Borough and has requested a determination from the Borough if a Land Development Plan is required.

Improvements include replacing an existing 120' high monopole with a new 150' high monopole with antennas, replacement of an existing 120 sq. ft. shelter with a new 30 sq. ft. shelter (building) with generator, proposed above-ground 1000 gallon propane tank and three future 300 sq. ft. equipment shelters.

Because the project involves the improvement of the lot with a non-residential building (one shelter and three future shelters), the Borough Engineer recommends that a Land Development Plan be required for this project pursuant to §325.5 of the Millersville Borough

Subdivision and Land Development Ordinance and be subject to the Stormwater Management Ordinance.

A Walker/Hess motion that the Millersville Borough Planning Commission recommends to the Millersville Borough Council approval of the waiver request for the Preliminary/Final Land Development Plan requirements, subject to conditions provided by the Borough Engineer as well as to show the fall zone radius and adjacent existing building and also to include that no generators to be allowed in the three future shelters to be shown on the plan.
