INDEMNITY AGREEMENT – SKATEBOARD ACTIVITIES
RELEASE

THIS RELEASE given by _____, with a mailing address of _____, hereinafter called "Applicant", in favor of the **BOROUGH OF MILLERSVILLE** (the "Borough"), a municipal corporation organized and existing under the laws of the Commonwealth of Pennsylvania.

BACKGROUND:

NOW, THEREFORE, in consideration for ability to use the Park from the Borough and intending to be legally bound Applicant agrees to release, defend, indemnify and hold harmless the Borough and its agents, servants, and employees from and against all liability, claims, damages, losses, and expenses, including attorneys' fees and costs of investigation, arising or resulting from entry into the Park and use of the Park for participation in skateboarding or other physical activities. Applicant assumes all risks and shall bear all loss resulting from injury to persons or property occasioned by his/her entry into the Park and participation in skateboarding or other related physical activities.

In the event that a third party, his agents, servants, employees, heirs, assigns, or grantees shall institute any legal action whatsoever against the Borough, its agents, servants, or employees for any of the reasons stated in this Release, Applicant agrees to further pay any and all attorneys fees, engineering fees, court costs, and/or any other expenses whatsoever incurred by the Borough in regard thereto.
