The Millersville Borough Department of Streets hereby approves the construction or alternation within the highway right-of-way to open _____ between _____ and _____ . The Contractor performing such work is _____ .

All work by the Permittee within the right-of-way of streets within the Borough shall be performed in accordance with the direction of the Borough. The Permittee shall use due diligence in the execution of the work authorized by this Permit and shall not obstruct or endanger travel. All work shall comply with Chapter 203, Work Zone Traffic Control, of the regulations of the Pennsylvania Department of Transportation and Chapter 21, Streets and Sidewalks, of the Borough Code of Ordinances.

Attach a Certificate of Insurance evidence liability insurance applicable to the work for at least \$500,000 for personal injury and death and for property damage. If the work will disturb more than 12 square yards of street surface, attach bond guaranteeing performance with requirements of Part 1 of Chapter 21 of the Code of Ordinances.

Permittee shall restore all disturbed portions of the highway, including slopes and all appurtenances and structures such as guard rail or drain pipes to a condition at least equal to that which existed before the start of any work authorized by the Permit. This includes providing appropriate end treatments on guard rail systems where existing guard rail is being broken by a driveway. Unless specifically authorized by the Permit, Permittee shall not alter the existing drainage pattern or the existing flow of drainage water.

Permittee covenants and agrees to fully indemnify and save harmless the Borough of Millersville and assume all liability for damage or injury, occurring to any person, persons, or property through or in consequence of any act or omission of anyone working on the construction.

In the event of Permittee's failure or neglect to perform and comply with the permit, the Borough may revoke and annul the permit and order and direct the Permittee to restore the right-of-way to its former condition.

NO APPLICATION IS COMPLETE WITHOUT FEE, CERTIFICATE OF INSURANCE, AND (if required) BOND.

I certify that all facts in this Application and all accompanying documentation are true and correct. This Application is being made by me to induce official action on the part of Millersville Borough, and I understand that any false statements made herein are being made subject to the penalties of 18 Pa. C.S. §4904 relating to unsworn falsification to authorities. I acknowledge that any violation of the terms of this Permit or of Chapter 21, Streets and Sidewalks, of the Cod of Ordinances of the Borough may result in the revocation of this Permit and constitutes a summary violation which, upon conviction thereof, may result in a fine of up to \$1,000.00 plus costs.
