ORDINANCE NO. _____

AN ORDINANCE TO AMEND THE MILLERSVILLE BOROUGH CODE OF ORDINANCES, CHAPTER 350, VEHICLES AND TRAFFIC, TO REVISE PARKING REGULATIONS.

BE AND IT IS HEREBY ORDAINED AND ENACTED by Borough Council of the Borough of Millersville, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of the Borough of Millersville, Chapter 350, Vehicles and Traffic, Article IV, Parking Regulations, §350-33, Parking Prohibited at all Times in Certain Locations, shall be amended by deleting the following parking prohibition:

<u>Street</u>	<u>Side</u>	<u>Between</u>
East Frederick Street	Both	George Street and Creek Drive

Section 2. The Code of Ordinances of the Borough of Millersville, Chapter 350, Vehicles and Traffic, Article IV, Parking Regulations, §350-33, Parking Prohibited at all Times in Certain Locations, shall be amended by inserting the following parking prohibitions in alphabetical order:

<u>Street</u>	<u>Side</u>	<u>Between</u>
East Frederick Street	Both	George Street and High School Avenue
East Frederic Street	South	George Street and Creek Drive
East Frederick Street	North	Creek Drive and a point 20 feet west
East Frederick Street	North	A point 293 feet west of Creek Drive and a point 82 feet west of the first point
East Frederick Street	North	George Street and a point 290 feet east

Section 3. All other sections, parts and provisions of the Code of Ordinance of the Borough of Millersville shall remain in full force and effect as previously enacted and amended.

Section 4. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.

Section 5. This Ordinance shall take effect and be in force from and after its enactment as provided by law.
