**A RESOLUTION OF MILLERSVILLE BOROUGH COUNCIL CONCERNING
ADMINISTRATION OF CHAPTER 110, ALARM SYSTEMS, OF THE CODE
OF ORDINANCES AND ESTABLISHMENT OF FALSE ALARM FEES**

WHEREAS, by Ordinance No. _____ Borough Council amended the Code of Ordinances to add a new Chapter 110, Alarm Systems; and

WHEREAS, Section 110-6 of Chapter 110 authorizes Borough Council by resolution to designate a Borough officer or the Blue Rock Fire Rescue as the fire department to administer the provisions of Chapter 110; and

WHEREAS, Section 110-3 authorizes Borough Council to establish a fee for responses to false alarms; and

WHEREAS, Borough Council desires to appoint Blue Rock Fire Rescue to administer Chapter 110 and to establish false alarm fees.

NOW, THEREFORE, BE IT RESOLVED by Borough Council of the Borough of Millersville, Lancaster County, Pennsylvania, as follows:

Section 1. In accordance with Section 110-6, Administration and Enforcement, of Chapter 110, Alarm Systems, of the Code of Ordinances, Borough Council designates Blue Rock Fire Rescue as the administrator and enforcement officer for Chapter 110 and authorizes Blue Rock Fire Rescue to collect and retain fees imposed under this Resolution to defray the costs which it incurs responding to false alarms.

Section 2. Borough Council imposes the following fees for false alarms as authorized by Section 110-3 of Chapter 110 of the Code of Ordinances:

E. Fifth or greater false alarm during a calendar year: \$300.00 for each false alarm.

Section 3. Borough Council reserves the right to revise the fees in this Resolution at any time by resolution.

Section 4. This Resolution shall not be deemed to repeal any other resolution of this Borough establishing fees, penalties, interest rates or charges. This Resolution shall be interpreted to amend only those fees, penalties and interest rates expressly set forth in this Resolution, and all other fees, penalties, interest rates and charges imposed by all other resolutions are hereby ratified and confirmed.

Section 5. In the event any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses, or parts of this Resolution, it being the intent of Borough Council that the remainder of the Resolution shall be and shall remain in full force and effect.

Section 6. This Resolution shall take effect and be in force immediately as provided by law.
